5.4.3 Request Procedure

The requester must submit a written enquiry to private@moveme.co.za

The requester must provide sufficient detail on the request that will allow MoveMe to identify the record and the requestor. The requester must indicate the form of access required

The requester must indicate the right that they are exercising or the right to be protected and provide an explanation of the record/s that are required to protect the right identified.

If the request is made on behalf of another person then proof of the capacity in which the requester is acting must be provided to the satisfaction of MoveMe.

5.4.4 Fees

A requester seeking access to a record that contains personal information about the requester is not required to pay a fee, if they use the website capabilities. This will require the requester to register on the website. If the record is required in any other form then an **access fee** is applicable.

MoveMe will notify any other requestor and will require the requestor to pay the **request fee** before processing the request. The requester may approach MoveMe to waive this fee or may lodge an application to the court against the tender or payment of the fee.

The current **request fee is R50** per SINGLE request per RECORD.

If the request is granted an **access fee of R50** is required to pay for the search, preparation and reproduction per RECORD.
